Storage and Disposal

Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 PSI for at least 30 seconds. Drain for 10 seconds after the flow begins to drip. Once properly rinsed, some plastic pesticide containers can be taken to a container collection site or picked up for recycling.
